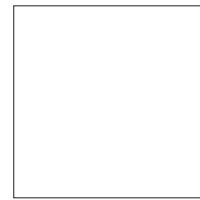

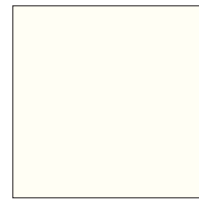

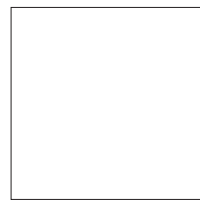

3. Vellum sleeves are available on our premium and deluxe packages. Vellum options are 30 lb weight with a translucent finish.

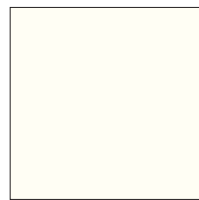

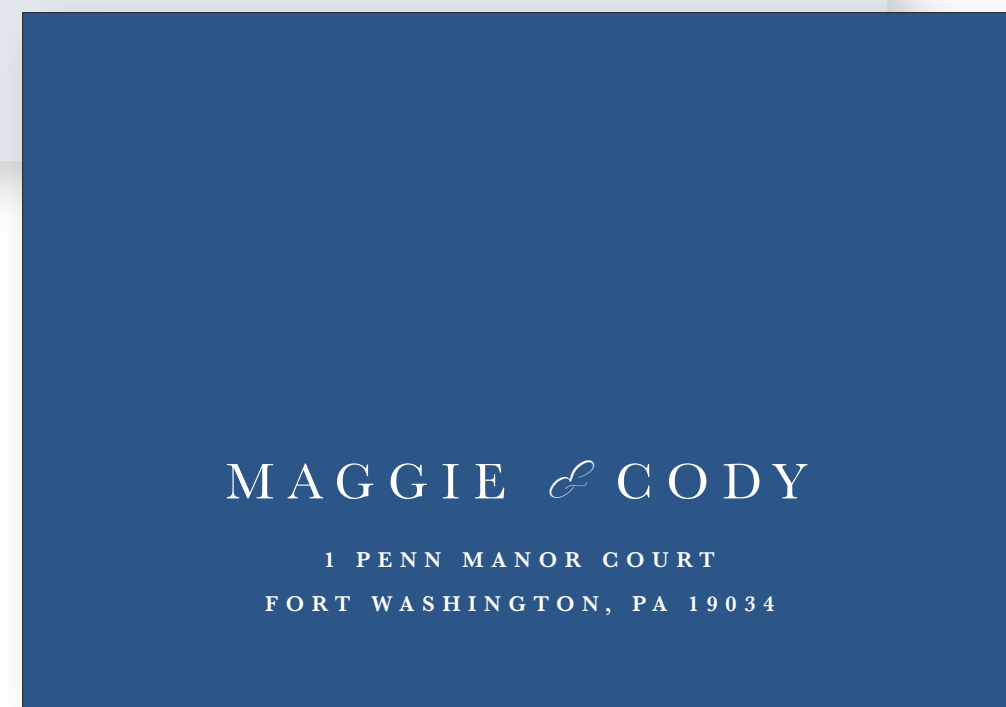
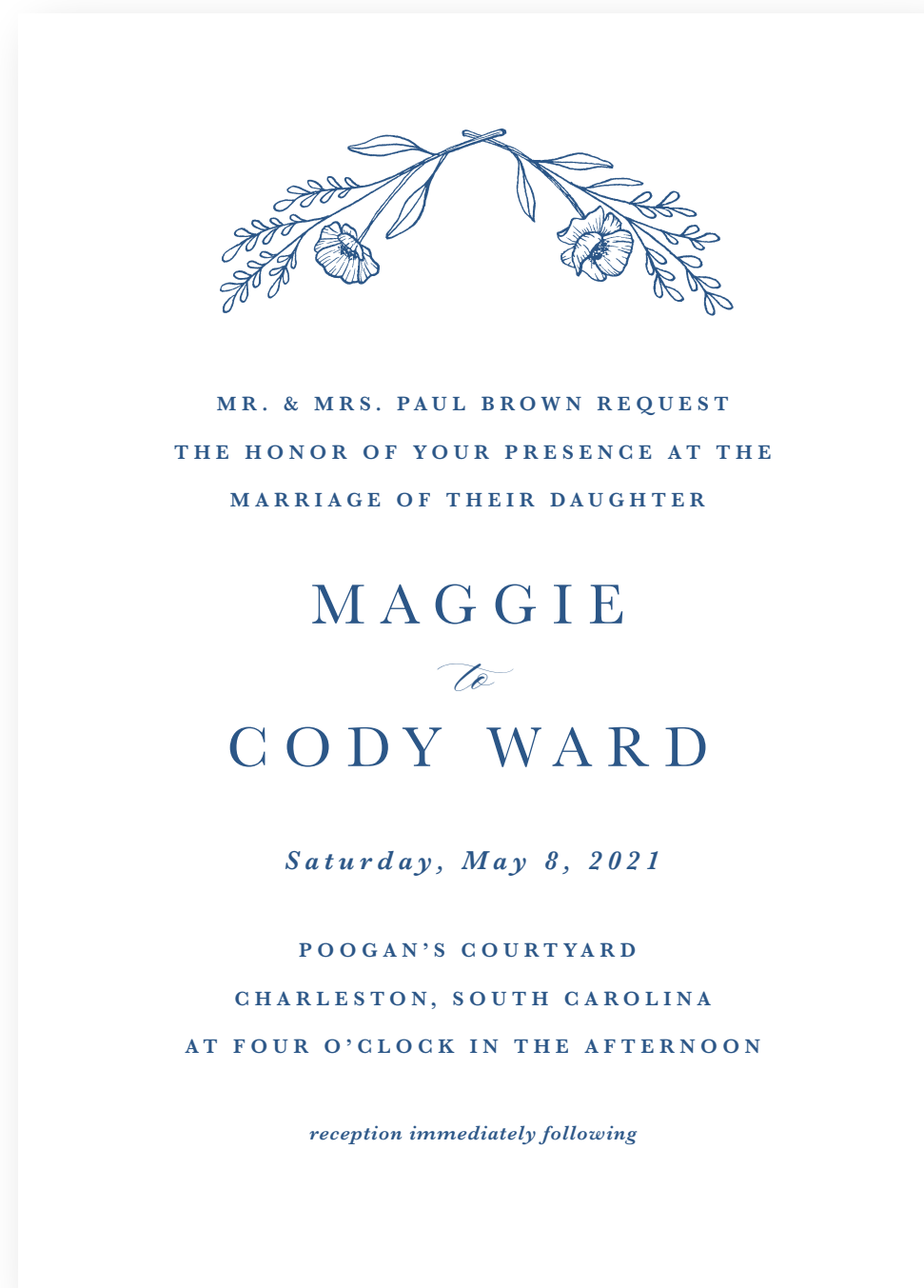


6. ASSEMBLED INVITATION
